**SUPPLEMENTARY DEED OF AGREEMENT**

**AUCKLAND SEVENTH-DAY ADVENTIST HIGH SCHOOL**

THIS DEED OF AGREEMENT is made on the 13<sup>th</sup> day of January two thousand and four (2004) BETWEEN THE NEW ZEALAND SEVENTH-DAY ADVENTIST SCHOOLS ASSOCIATION LIMITED being a body duly incorporated under the Companies Act 1955 (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

**WHEREAS**

- A By Deed of Agreement bearing the date of 28<sup>th</sup> day of January, one thousand nine hundred and ninety three (1993) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established the **Auckland Seventh-day Adventist High School** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clauses 20 and 21 (b) of the Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED, AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

1. **THAT** the words "two hundred and seventy (270) pupils" in the 4th line of clause 20 of the Deed of Agreement be deleted from that Agreement and the words "three hundred and forty (340) pupils" be substituted therefor.
2. That the words "shall be limited to 10% of the maximum roll of the School" in lines 4 and 5 of clause 21 (b) of the original Deed of Agreement be deleted, and the words "shall be limited to 27 pupils" be substituted therefor.
3. That the words "subject however that the maximum number of third form pupils shall not at any time exceed 60" added to clause 20 by the Integration Agreement dated 10 February 1995 be deleted.
4. That the covenants conditions and restrictions contained and implied in the Integration Agreements shall be read and construed subject to the modifications herein contained but in all other respects the Integration Agreements are confirmed.
