- A. By Deed of Agreement bearing the date the 26th day of March, 1993 as varied by a subsequent Supplementary Agreement bearing date the 20th day of December 1996 and the 7th day of April 1999 (hereinafter together referred to as 'the Integration Agreements"), the Minister and the Proprietor pursuant to Sections 7(2) and 7(9) of the Private Schools Conditional Integration Act 1975 established the Balmoral Seventh-day Adventist Primary School as an integrated school (hereinafter referred to as "the School")
- B. The Proprietor and the Minister are now agreed on amending Clause 20 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975 to further increase the maximum roll.

NOW THIS DEED WITNESSES AND IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS:-

- 1. That the words "maximum roll of the School shall be 90" in line 4 on page 6 of the Deed of Agreement be deleted, and the words "maximum roll of the School shall be 110" be substituted therefor.
- 2. That the terms conditions and agreement contained or implied in the Integration Agreements shall be read and construed subject to the modification herein contained by in all other respects the Integration Agreements are confirmed.
