SUPPLEMENTARY DEED OF AGREEMENT

BARADENE COLLEGE, REMUERA

THIS DEED OF AGREEMENT is made on the //w day of / are/
One thousand nine hundred and ninety-eight (1998) BETWEEN THE BARADENE
COLLEGE TRUST BOARD a body Corporate registered under the Religious
Charitable and Education Trusts Act 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 26th day of March 1983 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Baradene** College as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to change the class of the school to a Years 7 to 13 school consequent upon the closure of the attached Intermediate Department of the School pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 THAT the Integration Agreement be amended as follows:
- By deleting from **Recital B** the words "Form Three (III) to Form Seven (VII) with an attached Intermediate Department " and substituting the words "Years 7 to 13" therefor.
- By deleting Clause 8 and substituting the following Clause therefor: "The combined maximum rolls of Baradene College and the attached Intermediate Department totalled eight hundred (800) pupils as at the 7th day of August 1997. It is agreed by and between the parties hereto that the maximum roll of the school shall be eight hundred (800) pupils."
- By deleting from Clause 25 the words "from Form Three (III) to Form (VII) for girls only, with an Intermediate Department attached" and substituting therefor the words "for girls only from Years 7 to 13".
- 5 By deleting Clause 18 of the Deed of Agreement.

- By deleting from line 1 and from lines 12 and 13 of Clause 19 of the Deed of 6 Agreement the words "the Form III to Form VII section of".
- By deleting the Fifth Schedule to the Deed of Agreement. 7
- THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
