

SUPPLEMENTARY DEED OF AGREEMENT


THIS DEED OF AGREEMENT is made on the <sup>18<sup>th</sup></sup> day of <sup>August</sup>  
One Thousand nine hundred and eighty <sup>eight</sup> (198~~8~~) BETWEEN  
THE SOCIETY OF THE SACRED HEART TRUST BOARD a Body  
Corporate (hereinafter with its successors referred to as  
"the Proprietor") of the first part AND HER MAJESTY THE  
QUEEN acting by and through the Minister of Education  
(hereinafter referred to as "the Minister") of the second  
part

WHEREAS

- A By Deed of Agreement bearing date the 26th day of  
March 1983 as varied by any subsequent supplementary  
agreements (hereinafter referred to as "the Deed of  
Agreement"), the Minister and the Proprietor pursuant  
to section 7(2) of the Private Schools Conditional  
Integration Act 1975 established **Baradene College,**  
**Remuera** as an integrated school.
- B The Proprietor and the Minister are now agreed on the  
need to amend the Deed of Agreement pursuant to  
section 7(9) of the Private Schools Conditional  
Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY  
COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES  
HERETO AS FOLLOWS:

1. THAT the words "six hundred (600) pupils made up of  
a maximum of four hundred and seventy-five (475)" in  
the 7th and 8th line in clause 8 of the Deed of  
Agreement be deleted from that Agreement and the  
words "six hundred and fifty-five (655) pupils made

up of a maximum of five hundred and thirty (530)" be substituted therefor.

2. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
