

SUPPLEMENTARY DEED OF AGREEMENT

CARDINAL MCKEEFRY PRIMARY SCHOOL, WILTON, WELLINGTON

THIS DEED OF AGREEMENT is made on the *19th* day of *December* One thousand nine hundred and ninety-seven (1997) BETWEEN **THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON** a body Corporate registered under the Religious Charitable and Education Trusts Act 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 20th day of August 1979 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Cardinal McKeefry Primary School, Wilton, Wellington** as an integrated school (hereinafter referred to as "the School").
- B Pursuant to section 7(9) of the Act, the Proprietor and the Minister are now agreed to change the percentage of non-preference pupils in attendance at the school as specified in clause 10(b) of the Deed of Agreement.

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. THE Deed of Agreement is hereby amended by:
 - (a) Omitting from Clause 10b the words "shall be limited at all times to five (5) per cent," and
 - (b) Substituting the words "shall be limited at all times to ten (10) per cent of the maximum roll or twenty (20) per cent of the actual roll, whichever is the lesser number".
2. THAT the covenants, conditions and restrictions contained and implied in the Deed of Agreement shall be read together with Clause 1 of this Supplementary Deed of Agreement but in all other respects the Deed of Agreement is confirmed.





