

SUPPLEMENTARY DEED OF AGREEMENT CARMEL COLLEGE, MILFORD

THIS DEED OF AGREEMENT is made on the 15th day of February
One thousand nine hundred and eighty five (1985)

THE SISTERS OF MERCY (AUCKLAND) TRUST BOARD a body corporate registered under the Charitable Trusts Act 1957 (hereinafter with its successors referred to as "the proprietor") of the first part

AND

HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the

## WHEREAS

- A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 9th day of OCTOBER 1981 for Carmel College, Milford (hereinafter referred to as the "original Deed of Agreement")
- B. The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 signed a supplementary Deed of Agreement on the 26th day of APRIL 1984 (hereinafter referred to as the "first supplementary Deed of Agreement").
- C. The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED

AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS

FOLLOWS:-

THAT the words "five hundred and five (505) pupils"

in the 7th line in Clause 8 of the original Deed of Agreement be deleted

from that Agreement and the words "five hundred and forty five (545) pupils"
be substituted therefor.

THAT the Third Schedule to the original Deed of Agreement be amended on page number 26 of that Agreement by adding under the heading "Provide by new construction or remodelling" the following "2 Classrooms of 58m<sup>2</sup>."

These items are to be completed by 31 March 1987.
