SUPPLEMENTARY DEED OF AGREEMENT

CHRIST THE KING PRIMARY SCHOOL, BURNSIDE

THIS DEED OF AGREEMENT is made on the 215 day of James One thousand nine hundred and ninety (1992) BETWEEN
THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF CHRISTCHURCH a
"Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER
MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- By Deed of Agreement bearing date the 13th day of May 1980 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Christ the King Primary School, Burnside as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to redefine the Proprietor's Land and the School Premises as defined in the Second Schedule to the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT the Deed of Agreement bearing date the 13th day of May 1980 is hereby amended by deleting and cancelling the Second Schedule and annexed Plan.
- 2. THAT the Second Schedule and Plan attached to this Supplementary Deed of Agreement are hereby substituted as the Second Schedule and annexed Plan defining the School Premises in the Deed of Agreement.

THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
