

SUPPLEMENTARY DEED OF AGREEMENT

CORNERSTONE CHRISTIAN SCHOOL, PALMERSTON NORTH

THIS DEED OF AGREEMENT is made on the ^{third} ~~first~~ ^{March} day of December two thousand and ~~fourteen~~ ^{fifteen} (2014) BETWEEN **CORNERSTONE CHRISTIAN EDUCATION TRUST** ("the Proprietor"), an incorporated body under the Charitable Trusts Act 1957, and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister").

WHEREAS

- A By Deed of Agreement bearing the date of 9th day of September 1994 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Cornerstone Christian School, Palmerston North** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clauses 19.2 and 19.3 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

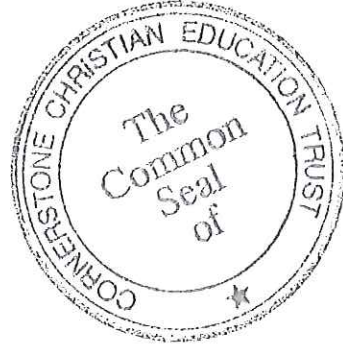
- 1 THAT in Clause 19.2 the words:
"To provide for parents a balanced Christian education to develop children to their full potential in God"
be deleted from the Integration Deed of Agreement and the following be substituted therefor:
"To provide, with parents, a balanced Christian education to help children develop to their full potential in God"
- 2 THAT in Clause 19.3 the words:
"The Special Character of the School is determined by the faith system made up of the Christian beliefs, values and lifestyle of the Palmerston North New Life Church as determined from time to time by the Trustees of the P.N. New Life Centre Charitable Trust"
be deleted from the Integration Deed of Agreement and the following be substituted therefor:
"The Christian Special Character of the School is determined by the faith system made up of the Christian beliefs, Biblical values and lifestyle as determined by the Trustees of the Cornerstone Christian Education Trust"



3 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
