

## SUPPLEMENTARY DEED OF AGREEMENT

### CORNERSTONE CHRISTIAN SCHOOL, PALMERSTON NORTH

THIS DEED OF AGREEMENT is made on the 3<sup>rd</sup> day of November two thousand and fifteen (2015) BETWEEN **Cornerstone Christian Education Trust** (the Proprietor") of the first part and **Her Majesty the Queen** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

#### WHEREAS

- A By Deed of Agreement bearing the date of the 9<sup>th</sup> day of September 1994 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Cornerstone Christian School, Palmerston North** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clauses 1, 21 and 30 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

#### NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** in Clause 21 the words: "Increases from 2016 are also subject to a positive Education Review Office readiness review on senior secondary student provision and NZQA course approval and accreditation" be deleted.
2. **THAT** in Clauses 1 and 30 the words "Year 1 to Year 9 Composite School from 27 January 2014 and Year 1 to Year 10 Composite School from 27 January 2015" be deleted from the Integration Agreement and the words Year 1 to Year 13 Composite School from 27 January 2016 be substituted therefor.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
