SUPPLEMENTARY DEED OF AGREEMENT CORNERSTONE CHRISTIAN SCHOOL

THIS DEED

OF AGREEMENT is made on the Win day of Dolar bod one thousand nine hundred and ninety nine (1999)

BETWEEN

P.N. New Life Centre Charitable Trust (hereinafter referred to as the "Proprietor"), an incorporated body under the Charitable Trusts Act 1957

AND

Her Majesty the Queen acting by and through the Minister of Education (hereinafter referred to as the "Minister").

WHEREAS

By Deed of Agreement bearing the date of the ninth day of September 1994, and the subsequent Supplementary Agreements of the tenth day of February 1995, nineteenth day of August 1997, seventeenth day of December 1998, twenty second day of March 1999, and ninth day of April 1999 (two agreements) (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Cornerstone Christian School as an integrated school (hereinafter referred to as "the School").

The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

School Roll

In Clause 1 on page 1 of the Supplementary Agreement of 22 March 1999 the 1. words:

"It is agreed that the maximum roll of the School shall be one hundred and sixty eight (168)"

shall be deleted from the Deed of Agreement and the following words substituted:

"It is agreed that the maximum roll of the School shall be two hundred and two (202)".

Second Schedule

The Second Schedule is changed by amending the site layout drawing SK10. 2. The school premises is all that part of the Proprietor's land described in the First Schedule which is delineated in green, together with the school buildings and other improvements delineated in red on the attached drawing SK10 Issue B.

That the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
