

SUPPLEMENTARY DEED OF AGREEMENT

CORNERSTONE CHRISTIAN SCHOOL, PALMERSTON NORTH

THIS DEED OF AGREEMENT is made on the 14 day of October two thousand and thirteen (2013) BETWEEN P.N. NEW LIFE CENTRE CHARITABLE TRUST ("the Proprietor"), an incorporated body under the Charitable Trusts Act 1957, and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister").

WHEREAS

- A By Deed of Agreement bearing date the 9th day of September 1994 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Cornerstone Christian School, Palmerston North** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clauses 1, 21 and 30 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 THAT in Clause 21 the words "two hundred and eighty (280)" be deleted from the Integration Deed of Agreement and the words "three hundred and forty (340)" be substituted therefor.
- 2 THAT in Clauses 1 and 30 the words "New Entrants to Form 2 Primary School" be deleted from the Integration Deed of Agreement and the words "Year 1 to Year 9 Composite School from 27 January 2014 and Year 1 to Year 10 Composite School from 27 January 2015" be substituted therefor.
- 3 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
