

SUPPLEMENTARY DEED OF AGREEMENT

CORNERSTONE CHRISTIAN SCHOOL, PALMERSTON NORTH

THIS DEED OF AGREEMENT is made on the ^{29th} day of ^{January} ~~fourteen~~ (2014) BETWEEN **CORNERSTONE CHRISTIAN EDUCATION TRUST** ("the Proprietor"), an incorporated body under the Charitable Trusts Act 1957, and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister").

WHEREAS

- A By Deed of Agreement bearing date the 9th day of September 1994 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Cornerstone Christian School, Palmerston North** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clauses 21 and 22.2 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 THAT in Clause 21 the words "three hundred and forty (340)" be deleted from the Integration Deed of Agreement and the words "four hundred (400) from 2015, four hundred and forty (440) from 2016, five hundred and twenty (520) from 2017, five hundred and fifty (550) from 2018, and five hundred and eighty (580) from 2020, subject to the Proprietor providing sufficient integrated teaching spaces for each increase in maximum roll, prior to the increase taking effect. Increases from 2016 are also subject to a positive Education Review Office readiness review on senior secondary student provision and NZQA course approval and accreditation." be substituted therefor.
- 2 THAT in Clause 22.2 "10%" be deleted from the Integration Deed of Agreement and "5%" be substituted therefor.
- 3 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
