

**SUPPLEMENTARY DEED OF AGREEMENT  
CORNERSTONE CHRISTIAN SCHOOL**

**THIS DEED OF AGREEMENT** is made on the 30<sup>th</sup> day of July two thousand and three (2003)

**BETWEEN** **P.N. New Life Centre Charitable Trust** (hereinafter referred to as the "Proprietor"), an incorporated body under the Charitable Trusts Act 1957

**AND** **Her Majesty the Queen** acting by and through the Minister of Education (hereinafter referred to as the "Minister").

**WHEREAS** By Deed of Agreement bearing the date of the ninth day of September 1994, and the subsequent Supplementary Agreements of the tenth day of February 1995, nineteenth day of August 1997, seventeenth day of December 1998, twenty second day of March 1999, ninth day of April 1999 (two agreements), the fourteenth day of December 1999, and the twenty eighth day of February 2001 (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Cornerstone Christian School as an integrated school (hereinafter referred to as "the School").

The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

**School Roll**

1. In Clause 1 on page 1 of the Supplementary Agreement of 28 February 2001 the words:

"It is agreed that the maximum roll of the School shall be two hundred and twenty eight (228)"


shall be deleted from the Deed of Agreement and the following words substituted:

"It is agreed that the maximum roll of the School shall be two hundred and fifty four (254)".

**Second Schedule**

2. The Second Schedule is changed by replacing the site layout drawing SK10 with drawing number: SITE dated 23 May 2003. The school premises is all that part of the Proprietor's land described in the First Schedule which is delineated in green, together with the school buildings and other improvements enclosed in the green area on the attached drawing.


That the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

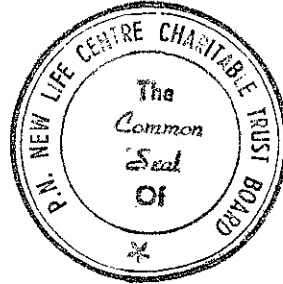



