

SUPPLEMENTARY DEED OF AGREEMENT

Craighead Diocesan School, Timaru

THIS DEED OF AGREEMENT is made on the 13 day of June
Two thousand and eleven (2011) between the **Craighead Diocesan School Proprietors**
(hereinafter referred to as "the Proprietor) of the first part and **HER MAJESTY THE**
QUEEN acting by and through the Minister of Education (hereinafter referred to as "The
Minister") of the second part

WHEREAS

- A. By Deed of Agreement bearing the date of **20th** day of **December 1980** as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 Craighead Diocesan School (hereinafter referred to as "the School") was established as an integrated school.
- B. The Proprietor and the Minister are now agreed to vary the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY
CONVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES
HERETO AS FOLLOWS:**

1. **THAT** the words "*The maximum roll of Year 7 to Year 13 pupils shall be 350 unless and until otherwise agreed by the Proprietor and the Minister*" in clause 9 of the Deed of Agreement (previously amended on the 21st day of August 2008) be deleted from the agreement and the words "*The maximum school roll shall be 380 pupils*" be substituted therefore.
2. **THAT** clause 11 of the Deed of Agreement (as amended on the 2nd day of February 1995) continue to limit pupils who do not have preference of enrolment to 5 percent of the maximum roll.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
