SUPPLEMENTARY DEED OF AGREEMENT

- B: The Proprietor and the Minister are now agreed on the need to amend Clause 9 and Clause 23 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional integration Act 1975.

NOW THIS DEED of agreement witnesseth that it is <u>HEREBY</u> COVENANTED AGREED AND DECLARED by and between the parties hereto as follows:

- 1. THAT the number "130" in the second line of clause 9 of the original Deed of Agreement be deleted from that Agreement and the number "165" be substituted therefor.
- 2. THAT the number "55" in the third line of clause 9 of the original Deed of Agreement be deleted from that Agreement and the number "75" be substitued therefor.
- 3: THAT the number "80" in the fourth line of clause 23 of the original Deed of Agreement be deleted from that agreement and the number "90" be substituted therefor.
- 4. THAT the number "130" in the fifth line of Clause 23 of the original Deed of Agreement be deleted from that Agreement and the number "165" be substituted therefor.
- 5. THAT the covenants conditions and restrictions contained and implied in the original Deed of Agreement be read and construed subject to the modifications herein contained but in all other respects the original Deed of Agreement is confirmed.
