THIS DEED made this 23rd day of *January* 1995

BETWEEN CRAIGHEAD DIOCESAN SCHOOL BOARD OF PROPRIETORS
being the Proprietor of Craighead Diocesan School, Timaru the said Proprietor being a body duly incorporated under the Religious Charitable and Education Trust Act 1908 pursuant to a Statute of the Synod of Diocese of Christchurch and having its registered office at 39 George Street, Timaru (hereinafter together with its successors and assigns called "the Proprietor") of the first part

A N D HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter called "the Minister") of the second part

WHEREAS

- A. The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 (hereinafter referred as ("the Integration Act")) signed a Deed of Agreement on the 20th day of November 1980 for Craighead Diocesan School, Timaru (hereinafter referred to as "the Original Deed").
- B. The Proprietor and the Minister pursuant to Section 7 (9) of the Integration Act signed a Supplementary Deed dated the 18th day of October 1983 (hereinafter referred to as "the First Supplementary Deed") amending clause 9 and clause 23 of the Original Deed.
- C. The Proprietor and the Minister pursuant to Section 7(9) of the Integration Act signed a Second Supplementary Deed on the 23rd day of June 1992 (hereinafter referred to as "the Second Supplementary Deed") further amending clause 9 and clause 23 of the Original Deed as amended by the First Supplementary Deed.

- D. The Proprietor and the Minister pursuant to Section 7(9) of the Integration Act signed a Third Supplementary Deed on the 26th day of April 1993 (hereinafter called "the Third Supplementary Deed") amending clause 1 and clause 33 of the Original Deed.
- E. The Proprietor and the Minister signed a Fourth Supplementary Deed on the 24th day of December 1993 (hereinafter referred to as "the Fourth Supplementary Deed") further amending clause 9 and clause 23 of the original Deed as amended by the First Supplementary Deed and the Secondary Supplementary Deed pursuant to Section 7(9) of the Integration Act.
- F. The Proprietor and the Minister signed a Fifth Supplementary Deed on the 3rd day of February 1995 (hereinafter referred to as "the Fifth Supplementary Deed") making various amendments to the original Deed as therein set out.
- G. The Proprietor and the Minister are now agreed that the original Deed as amended by the Second Supplementary Deed substituting the Plan defining boundaries be substituted for a further Plan redefining the boundaries.

NOW THEREFORE THIS DEED witnesseth and it is HEREBY COVENANTED AGREED AND DECLARED by and between the parties hereto that:

- 1. The Plan attached hereto prepared by Milward Finlay Lobb Limited, Consulting Engineers and Registered Surveyors of 6 The Terrace, Timaru, designated "Craighead Diocesan School (Client and Job No. 121968/2)" shall be substituted for the Plan annexed to the Second Supplementary Deed, such further Plan defining the following:

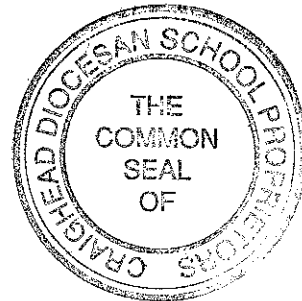
- (a) Boundary of the Proprietor's land edged green.
- (b) Boundary of the integrated area edged red.
- (c) Buildings within the integrated area that are not to be integrated edged blue.

GENERAL

2. That the covenants, conditions and restrictions contained and implied in the Original Deed be read and construed subject to the modifications herein contained but in all other respects the Original Deed is confirmed.
