CRAIGHEAD DIOCESAN SCHOOL, TIMARU

THIS DEED is made this 24th day of De cember 1993

BETWEEN CRAIGHEAD DIOCESAN SCHOOL PROPRIETORS being the proprietor of Craighead Diocesan School, Timaru the said proprietor being a body duly incorporated under the Religious Charitable and Education Trust Act 1908 pursuant to a Statute of the Synod of Diocese of Christchurch and having its registered office at 39 George Street, Timaru (hereinafter together with its successors and assigns called "the Proprietor") of the first part

A N D HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter called "the Minister") of the second part

WHEREAS

- A. The Proprietor and the Minister pursuant to Section 7
 (2) of the Private Schools Conditional Integration Act
 1975 signed an integration agreement on the 20th day of
 November 1980 for Craighead Diocesan School, Timaru
 (hereinafter referred to as "the Original Deed").
- The Proprietor and the Minister pursuant to Section 7 В. subsection (9) of the Integration Act signed Supplementary Deed of Agreement dated the 18th day of October 1983 amending clause 9 and clause 23 of the Original (hereinafter referred Deed to the "Supplementary Deed").
- C. The Proprietor and the Minister signed a Second Supplementary Deed on the 23rd day of June 1992 whereby they agreed to further amend clause 9 and clause 23 of

the Original Deed as amended by the Supplementary Deed pursuant to Section 7 subsection (9) of the Integration Act.

- D. The Proprietor and the Minister signed a Third Supplementary Deed on the 26th day of April 1993 amending clause 1 and clause 33 of the Original Deed of Agreement.
- E. The Proprietor and the Minister are now agreed to further amend clause 9 and clause 23 of the Original Deed of Agreement as amended by the Supplementary Deed and the Second Supplementary.

NOW THIS DEED of agreement witnesseth that it is HEREBY COVENANTED AGREED AND DECLARED by and between the parties hereto as follows:

CLAUSE 9 ORIGINAL DEED

2. THAT the number <u>EIGHTY</u> "80" substituted by the Second Supplementary Deed of agreement in the third line of clause 9 of the Original Deed be deleted from the Original Deed and the number <u>NINETY</u> "90" be substituted therefore.
