THE THIRD SUPPLEMENTARY DEED OF AGREEMENT CRAIGHEAD DIOCESAN SCHOOL, TIMARU

THIS DEED is made this 26 h day of April 19 93.

CRAIGHEAD DIOCESAN SCHOOL PROPRIETORS BETWEEN being the proprietor of Craighead Diocesan School, Timaru, the said proprietor a body duly incorporated under the Religious Charitable Education Trust Act 1908 pursuant to a Statute of Diocese of Christchurch and Synod of having registered office at George Street, Timaru (hereinafter together with its successors and assigns called Proprietor") of the first part

A N D HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter called "the Minister") of the second part

WHEREAS:

- A. The Proprietor and the Minister pursuant to Section 7
 Subsection 2 of the Private Schools Conditional
 Integration Act 1975 signed an Integration Agreement on
 20th November 1980 for Craighead Diocesan School,
 Timaru (hereinafter referred to as "the original Deed
 of Agreement").
- B. The Proprietor and the Minister pursuant to Section 7(9) of the Integration Act signed a Supplementary Deed of Agreement dated the 18th day of October 1983 amending Clause 9 and Clause 23 of the original Deed (hereinafter referred to as "the Supplementary Deed").
- C. The Proprietor and the Minister signed a second Supplementary Deed on the 23rd day of June 1992 whereby they agreed to further amend Clause 9 and Clause 23 of the original Deed as amended by the Supplementary Deed pursuant to Section 7(9) of the Integration Act.

- D. Pursuant to a Statute of the Synod of the Diocese of Christchurch the name <u>CRAIGHEAD DIOCESAN SCHOOL TRUST BOARD</u> having its registered office at George Street, Timaru was changed to <u>CRAIGHEAD DIOCESAN SCHOOL PROPRIETORS</u> having its registered office at George Street, Timaru, such change having taken effect from the 1st day of February 1990.
- E. The Proprietor and the Minister are now agreed to further amend the original Deed by amendment to Clause 1 and the addition of a further Clause 33 pursuant to Section 7(9) of the Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH AND IT IS HEREBY COVENANTED, AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO as follows:

1. THAT Clause 1 of the original Deed be amended by adding to the clause the following words:

"and an attached intermediate

2. THAT the original Deed be amended by the addition of a further clause 33 that states as follows:

"33. IT is agreed by the parties hereto that the maximum of the attached intermediate roll shall be 28 pupils unless and until otherwise agreed by the Proprietor and the Minister. The date for commencement of the Intermediate School shall be 1st January 1993."
