SUPPLEMENTARY DEED OF AGREEMENT

DE LA SALLE COLLEGE, MANGERE EAST

THIS DEED OF AGREEMENT is made on the 14th day of February

One thousand nine hundred and eighty-five (1985) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 24th day of November 1981 for De La Salle College, Mangere East (hereinafter referred to as the "original Deed of Agreement").
- B The Proprietor and the Minister pursuant to Section 7 (9) of the Private Schools conditional Integration Act 1975 signed a second supplementary Deed of Agreement on the 14th day of May 1984 (hereinafter referred to as the "second supplementary Deed of Agreement").
- C The Proprietor and the Minister are now agreed on the need to further amend Clause 8 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975 as amended by the second supplementary Deed of Agreement.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

- 1 THAT the second sentence beginning "It is agreed..." in Clause 8 of the original Deed of Agreement be deleted from that agreement

and the sentence "It is agreed by and between the parties hereto that the maximum roll of Forms III - VII of the school shall be five hundred (500) pupils and of Forms I - II of the School shall be two hundred and forty (240) pupils." be substituted therefor.

2 THAT the covenants conditions and restrictions contained and implied in the original deed of agreement shall be read and construed subject to the modifications herein contained but in all other respects the original deed of agreement is confirmed.
