

## SUPPLEMENTARY DEED OF AGREEMENT

### DE LA SALLE COLLEGE, MANGERE EAST, MANUKAU, AUCKLAND

THIS DEED OF AGREEMENT is made on the 26 day of February, two thousand and nine (2009) BETWEEN **THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND** a "corporation Sole" (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

### WHEREAS

- A By Deed of Agreement bearing date the 24<sup>th</sup> day of November, one thousand nine hundred and eighty-one (1981) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **De La Salle College, Mangere East, Manukau, Auckland** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

1. **THAT** the words "nine hundred and thirty (930) pupils" in the 6th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "one thousand (1000) pupils" be substituted therefor.
2. **THAT** in clause 10 (b) of the Deed of Agreement the words "thirty-four (34) pupils out of the total roll" be deleted from that Agreement and the words "five (5) percent of the maximum roll within five years" be substituted therefor.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
