

SUPPLEMENTARY DEED OF AGREEMENT

ELIM CHRISTIAN COLLEGE, HOWICK, AUCKLAND

THIS DEED OF AGREEMENT is made on the 7 day of December ~~2010~~ 2011 between the **Auckland East City Elim Church Trust** ("the Proprietor") and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education ("The Minister").

BACKGROUND

- A** By Agreement of 16 June, 1997 as varied by any subsequent supplementary agreements ("the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Elim Christian College, Howick, Auckland**, then known as Cascade Christian College, as an integrated school ("the school").
- B** The Proprietor and the Minister wish to vary the deed of Agreement to amend clause 20 and remove clause 21 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

THE PARTIES AGREE AS FOLLOWS:

1. **THAT** clause 20 of the Deed of Agreement be replaced with the following:
 20. It is agreed that the maximum roll of the school is currently 560 students and shall be 850 students from February 2012. Subject to confirmation from the Ministry's Auckland Office the maximum roll will increase to 1000 students from February 2013 (confirmation to be sought by the Proprietor before October 2012).
2. **THAT** clause 21 of the Deed of Agreement be deleted and not replaced.



3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications contained in this Supplementary Deed but in all other respects the Deed of Agreement is confirmed.
