

SUPPLEMENTARY DEED OF AGREEMENT

EMMANUEL CHRISTIAN SCHOOL, CHRISTCHURCH

THIS DEED OF AGREEMENT is made on the *2nd* day of *September* two thousand and thirteen (2013) BETWEEN **EMMANUEL PROPRIETOR TRUST** ("the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A** By Deed of Agreement bearing date the 26th July 1996 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Emmanuel Christian School, Christchurch** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to amend Clauses 1 and 20 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSES THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** in Clause 1 of the Integration Deed of Agreement the words "primary school pursuant to the Act catering for girls and boys from New Entrants to Form 2." be deleted and the words "Years 1-10 restricted composite school pursuant to the Act catering for boys and girls effective over two years, starting with Year 9 pupils from 27 January 2014 and then Year 10 pupils from 27 January 2015." be substituted therefor.
2. **THAT** in Clause 20 of the Integration Deed of Agreement the words "one hundred and seventy five (175) be deleted" and the words "two hundred and seventy five (275) effective from 27 January 2014" be substituted therefor.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
