the Incorporated Societies Act 1908

Her Majesty the Queen acting by and through the Minister of Education ("The Minister")

Background

- A. The Proprietor is the owner of Emmanuel Christian School ("The School")
- B. The Minister and the Proprietor have previously agreed on the 26th day of July 1996 to the integration of the School pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 ("The Act")
- C. The Minister and the Proprietor have previously agreed on the 26th day of April 2000 to relocate the operation of The School to 322 Sawyers Arms Road.
- D. The Minister and the Proprietor have previously agreed on the 31st October 2001 to increase the maximum roll to 120
- E. The Minister and Proprietor on the 21st July 2004 to a further increase of the Proprietors land and improvements into the school premises, bringing the total integrated school premises to 2.5 hectares.
- F. The Minister and Proprietor have previously agreed on the 5th October 2004 to increase the maximum roll to 130
- G. The Minister and Proprietor have previously agreed on the 30th July 2007 to increase the maximum roll to 140
- H. The Minister and Proprietor have previously agreed on the 15th September 2008 to increase the maximum roll to 175
- I. The Minister and Proprietor have agreed to a further increase of the Proprietors land into the integrated School premises, bringing the total integrated school premises to 3.4813 hectares more or less..

Now this deed witnesses and it is agreed between the parties as follows

- 2. The Second Schedule to the supplementary deed of agreement made on the 21st July 2004 is hereby amended by substituting the plan of the Proprietor's land, delineated in red, annexed to that supplementary deed of agreement in place of the plan of the Proprietor's land annexed to the original deed of agreement

Integrated 2. The integrated school premises shall increase to 3.4813 hectares more more or less
