## SUPPLEMENTARY DEED OF AGREEMENT

KAMO CHRISTIAN COLLEGE, WHANGAREI

THIS DEED OF AGREEMENT is made on the 24<sup>th</sup> day of June two thousand and four (2004) BETWEEN

NORTHLAND CHRISTIAN FELLOWSHIP INCORPORATED SOCIETIES ACT 1957 (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by the through the Minister of Education (hereinafter referred to as "The Minister" of the second part.

### WHEREAS

- A. By Deed of Agreement bearing date the 26<sup>th</sup> day of September 1996 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Kamo Christian College as an integrated school (hereinafter referred to as "the School").
- B. The Proprietor and the Minister are now agreed on the need to amend Clause 20 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS

1. **THAT** the words 150 in the 4<sup>th</sup> line in clause 20 of the Deed of Agreement be deleted from that Agreement and the words 200 be substituted therefore.
2. **THAT** the words in clause 21.2 of the Deed of Agreement "shall be limited to 5% of the roll at the School, with no more that 5% non-preference students at each of the Intermediate and Secondary levels" be deleted from that Agreement and the words "shall be limited to a set nominal amount of 10 pupils, be substituted therefore.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
