## SUPPLEMENTARY DEED OF AGREEMENT

## FAITH ACADEMY SCHOOL

THIS DEED OF AGREEMENT is made on the 16th day of May Two Thousand (2000) between WANGANUI ASSEMBLY OF GOD PROPERTY TRUST BOARD OF WANGANUI (hereinafter referred to as "The Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and the Minister of Education (hereinafter referred to as "The Minister") of the second part.

- THAT the words "one hundred and twenty five" (125) in the 3rd line of clause 20 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and fifty" (150) be substituted therefor.
- 2 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
