## SUPPLEMENTARY DEED OF AGREEMENT

## FAITH ACADEMY SCHOOL

One Thousand Nine Hundred and Ninety Six (1996) between WANGANUI ASSEMBLY OF GOD PROPERTY TRUST BOARD OF WANGANUI (hereinafter referred to as "The Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

## WHEREAS

A By deed of Agreement bearing date the Twenty Second Day of May, One thousand, nine hundred and ninety five (1995) as varied by any supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Faith Academy, Wanganui as an integrated New Entrant to Form 2 Primary School (hereinafter referred to as "The school").

B The Proprietor and the Minister are now agreed on the need to amend Clause 20 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETOFORE AS FOLLOWS:

1 THAT the words "ninety" (90) in the 3rd line of clause 20 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and twenty five" (125) be substituted therefor.

2 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
