SUPPLEMENTARY DEED OF AGREEMENT

HAMILTON SEVENTH-DAY ADVENTIST SCHOOL

This deed

is made on the 20h day of December 1996

between

The New Zealand Seventh-day Adventist Schools Association Limited being the proprietor of the Hamilton Seventh-day Adventist School the said proprietor being a body duly incorporated under the Companies Act 1955 (hereinafter together with its successors and assigns called "the Proprietor") of the first part

and

Her Majesty the Queen acting by and through the Minister of Education (hereinafter called "Minister") of the second part

whereas

- A. The Proprietor and the Minister pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on 26 July 1993 for the Hamilton Seventh-day Adventist School (hereinafter referred to as "the original Deed of Agreement")
- B. The Proprietor and the Minister are now agreed on the need to amend clauses 20 and 25 of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.
- C. The Proprietor and the Minister are now agreed on the need to prepare an additional plan to record the increase in the integrated school premises to be annexed to Schedule 2 of the original Deed of Agreement.

Now this deed of agreement witnesseth that it is hereby covenanted agreed and declared by and between the parties hereto as follows:

- 1. That the number "45" in the fourth line of clause 20 of the original Deed of Agreement be deleted from that agreement and the number "75" be substituted therefor.
- 2. That clause 25 of the original Deed of Agreement shall be replaced by the following:

Hamilton Seventh-day Adventist School

"For the purposes of Section 65(1)(c) the position of all teachers other than the Principal shall be positions of importance carrying a responsibility for religious instruction. Advertisements for these positions shall state that a willingness and ability to take part in religious instruction appropriate to the Special Character of the School shall be an essential condition of appointment. Such advertisements shall also state that a willingness and ability to uphold the Special Character shall be a condition of appointment."

- 3. That the plans attached to the **Second Schedule** of the original Deed of Agreement identifying all of the School premises forming part of the Integrated School be replaced by the amended plans attached hereto.
- 4. That the covenants conditions and restrictions contained and implied in the original Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the original Deed of Agreement is confirmed.
