SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED OF AGREEMENT is made on the 26 day of November 2008

BETWEEN **The Hawke's Bay Christian School Association Incorporated**, an incorporated body under the provision of the Charitable Trust Act 1957 ("the Proprietor")

AND **Her Majesty The Queen** acting by and through the Ministry of Education ("the Minister").

WHEREAS

- A By Deed dated 30 September 1999 (hereinafter referred to as "the Deed") the Minister and the Proprietor, pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975, established Hastings Christian School as an integrated school (hereinafter referred to as "the School").
- B From time to time the Minister and the Proprietor have varied the Deed by Supplementary Deed of Agreement, including by Supplementary Deed of Agreement dated 30 October 2007 (the "Supplementary Agreement").
- C The Proprietor desires to vary the Deed and the Supplementary Agreement in the manner set forth in this Deed, and the Minister has agreed to such changes pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THEREFORE THIS DEED OF AGREEMENT WITNESSETH AND IT IS AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. THAT Clause 1 of the Deed be amended by deleting the words "Year 1 to 10" and replacing them with the words "Year 1 to 13".
2. THAT Clause 1 of the Supplementary Agreement dated 30 October 2007 be deleted.
3. THAT Clause 20 of the Deed be amended by deleting the words "the maximum roll of the School shall be 140" and replacing them with the words "the maximum roll of the School shall be 220".
4. THAT the covenants and restrictions contained in the Deed and the Supplementary Agreement shall henceforth be read and construed subject to the modifications set out in this Deed but in all respects the Deed and the Supplementary Agreements are confirmed.

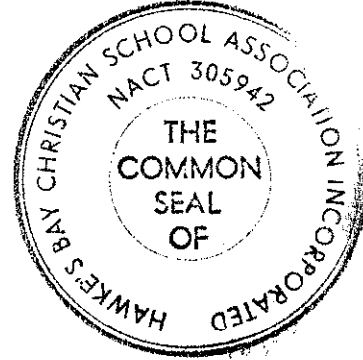
