

SUPPLEMENTARY DEED OF AGREEMENT

HOLY CROSS SCHOOL, PAPATOETOE

THIS DEED OF AGREEMENT is made on the 21 day of October

One thousand nine hundred and eighty-two (1982) BETWEEN

THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND

a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part AND HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "the Minister") of the second part

WHEREAS

- A The Proprietor and the Minister pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 signed an integration agreement on the 21st day of December 1981 for Holy Cross School, Papatoetoe (hereinafter referred to as the "original Deed of Agreement")
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 and the Third Schedule of the original Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:-

1. THAT the words "four hundred and thirty-nine (439) pupils" in the 5th line in Clause 8 of the original Deed of Agreement be deleted from that Agreement and the words "four hundred and fifty-three (453) pupils" be substituted therefor.

2. THAT the words "classroom area totalling 164m²" and "storage area of 10m²" appearing under the heading "BUILDING REQUIREMENTS" in the Third Schedule on page number 32 of the original Deed of Agreement be deleted from that agreement and the following words be inserted in substitution thereof: "classroom area totalling 229m²"
"storage area of 24m²".
