

SUPPLEMENTARY DEED OF AGREEMENT

HOLY FAMILY SCHOOL, WANAKA

THIS DEED OF AGREEMENT is made on the 7th day of AUGUST two thousand and seventeen (2017) BETWEEN **THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF DUNEDIN**, a "Corporation Sole" (hereinafter with its successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A** By Deed of Agreement bearing date the 18th day of December, two thousand and five (2005) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Holy Family School, Wanaka** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to section 423(3) of the Education Act 1989.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the words "one hundred and fifty two (152) at January 2015, with the roll increased to one hundred and ninety (190)" in Clause 8 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and twenty five (225)" be substituted therefor.
2. **THAT** in clause 10(b) of the Deed of Agreement the words ten percent (10%) of the maximum roll remains.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

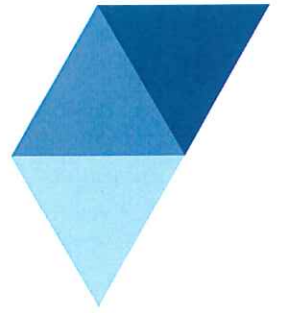

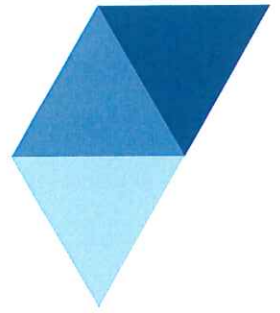
