

SUPPLEMENTARY DEED OF AGREEMENT

IONA COLLEGE, HAVELOCK

THIS DEED OF AGREEMENT is made on the ~~29th~~ ^{7th} day of ~~November~~ ^{December} Two thousand and eleven (2011) between **Iona College Council** (hereinafter referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A** By Deed of Agreement bearing date the 22nd day of December, one thousand nine hundred and ninety eight (1998) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Iona College, Havelock** as an integrated school (hereinafter referred to as "the school").
- B** The Proprietor and the Minister are now agreed to vary the Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the words "two hundred and fifty (250) students of which up to one hundred (100) may be day pupils" in the 3rd line of clause 20 of the Deed of Agreement be deleted from that Agreement and the words "in **2012** two hundred and sixty (260) students of which up to one hundred and seven (107) may be day pupils; in **2013** two hundred and seventy (270) students of which up to one hundred and fourteen (114) may be day pupils; in **2014** two hundred and eighty (280) students of which up to one hundred and twenty one (121) may be day pupils; in **2015** two hundred and ninety (290) students of which up to one hundred and twenty eight (128) may be day pupils; and in **2016** three hundred (300) students of which up to one hundred and thirty four (134) may be day pupils" be substituted therefore.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.


