BETWEEN HER MAJESTY THE QUEEN acting by and through the Minister
of Education (hereinafter referred to as "The Minister")

AND IONA COLLEGE acting by and through the General Assembly
of the Presbyterian Church of New Zealand, as defined by
the Presbyterian Church Property Act 1885 and the
Presbyterian Church of Aotearoa New Zealand under a
certain Deed of Trust dated the 5th day of November
1913, namely Alfred Isaac Dixon of Havelock North,
Financial Consultant and Pauline Ovena Campbell of
Hastings, Farmer and Rodney Gerald Gallen of Havelock
North, Retired Judge, and their successors from time to
time including any board incorporated by them pursuant
to the Charitable Trusts Act 1957 ("the Proprietors")

WHEREAS

- A By Deed of Agreement bearing date the 22nd day of
December one thousand nine hundred and ninety eight
(1998) as varied by any subsequent supplementary
agreements (hereinafter referred to as "the Deed of
Agreement") the Minister and the Proprietor pursuant
to section 7(2) of the Private Schools Conditional
Integration Act 1975 established Iona College, Havelock
North, as an integrated school (hereinafter referred to
as "the School")
- B The Minister and the Proprietor wish to vary the Deed
of Agreement to replace the Plan attached to the
Second Schedule with a new Plan pursuant to section
7(9) of the Private Schools Conditional Integration Act
1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED
AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. THAT the Plan annexed to the Second Schedule of the
Deed of Agreement be deleted and the Plan annexed hereto
be substituted therefor.
2. THAT the covenants conditions and restrictions
contained and implied in the Deed of Agreement shall be
read and construed subject to the modifications herein
contained but in all other respects the Deed of
Agreement is confirmed.
