

## SUPPLEMENTARY DEED OF AGREEMENT

THIS DEED is made on the 1<sup>st</sup> day of December 1994 between JOHN McGLASHAN PRESBYTERIAN COLLEGE BOARD (referred to as "The Proprietors"), an incorporated society registered under the incorporated Societies Act, and HER MAJESTY THE QUEEN, acting by and through the Minister of Education (referred to as "The Minister").

### WHEREAS

- A By Deed of Agreement bearing date the 30th day of January 1989, as varied by subsequent supplementary agreements dated the 6th day of July 1989 and 30th day of July 1992 (hereinafter referred to as "the Deed of Agreement"), the Minister and Proprietor pursuant to section 7 (2) of the Private School's Conditional Integration Act 1975 established John McGlashan College, Dunedin (hereinafter referred to as "the School") as an integrated school.
- B The Minister and the Proprietor have agreed to vary the Deed of Agreement for the Integration of the School whereby Clause 20 of the Deed of Agreement is varied pursuant to section 7 (9) of the Private Schools' Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**


