

DEED dated 25 day of November 2011

PARTIES

**HER MAJESTY THE QUEEN acting by and through the Minister of Education ("Minister")
CELEBRATION TRUST (the "Proprietor")**

SUPPLEMENTARY AGREEMENT TO UPDATE SITE PLANS ON KAIKOHE CAMPUS

WHEREAS

- A. The Proprietor is the owner of the Kaikohe Christian School ("School") by Deed of Agreement bearing the date 18th July 1997, as varied by subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"). The Minister and the Proprietor agreed to the integration of the School pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975.
- B. Pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975 the Minister and the proprietor have agreed to vary the Deed of Agreement by this supplementary agreement in order to integrate additional land and buildings on the Kaikohe campus (First and Second Schedule) so as to bring the available teachings spaces closer to Ministry standards in the Schools Property Guide.

The parties agree as follows:

VARIATION OF SUPPLEMENTARY AGREEMENT


- 1. The **FIRST SCHEDULE** as varied by the Supplementary Deed of Agreement date 24th August 2005 shall be varied as follows: **THE PROPRIETOR'S LAND** That after the words "Kohewhata No. 29c, block M.L.10176" be added the words "and "2520m² of Part Kohewhata 29F Block."
- 2. The **SECOND SCHEDULE** as varied by the Supplementary Deed of Agreement dated August 2005 shall be varied as follows:
 - a. The words "TOGETHER WITH, all the School buildings and other improvements thereon SAVE AND EXCEPT those buildings more particularly delineated in blue on the annexed Plan hereto" shall be deleted.
 - b. That the plans describing the land and buildings on the Kaikohe Campus, forming part Second Schedule be replaced with the annexed updated plans.
- 3. **GENERAL**
The Minister and the Proprietor agree that this supplementary agreement only varies the Supplementary Agreement to the Integration Agreement to the extend set out in this deed.
