

SUPPLEMENTARY DEED OF AGREEMENT ABUNDANT LIFE SCHOOL

**THIS DEED
OF AGREEMENT**

is made on the 11th day of December
two thousand and two (2002)

BETWEEN

Kaitaia Abundant Life Centre Trust (hereinafter referred to as the "Proprietor), an incorporated body under the Charitable Trusts Act 1957

AND

Her Majesty the Queen acting by and through the Minister of Education (hereinafter referred to as the "Minister")

WHEREAS

By Deed of Agreement bearing date the twenty-ninth day of March 1996 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7 (2) of the Private Schools Conditional Integration Act 1975 established Kaitaia Abundant Life School as an integrated school (hereinafter referred to as "the School").

The Proprietor and the Minister are now agreed on the need to amend the Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

**NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS
HEREBY COVENANTED AGREED AND DECLARED BY AND
BETWEEN THE PARTIES HERETO AS FOLLOWS:**

**School
Roll**

1. In Clause 21 on page 4 the words:

"the maximum roll of the School shall be 175"

shall be deleted from the Deed of Agreement and the following words substituted therefore:

"the maximum roll of the School shall be two hundred and fifteen (215)."

Enrolment

1. In Clause 22.2 on page 5 (five) the words:

"the number of pupils whose parents do not have preference of enrolment at the School is accordance with the provision of Section 29 (1) of the Act shall be limited to 10% of the roll at the School"

shall be deleted from the Deed of Agreement and the following words substituted therefore:

"the number of pupils whose parents do not have preference of enrolment at the School in accordance with the provisions of Section 29 (1) of the Act shall be limited to 17 students on the roll at the School."
