SUPPLEMENTARY DEED OF AGREEMENT

JIREH SATELLITE CAMPUS, HENDERSON**


THIS DEED OF AGREEMENT is made on the 28 day of January two thousand and ten (2010) between the **Kingsway Trust** a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A** By Deed of Agreement bearing date the 7th day of February, two thousand and six (2006) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Kingsway School's Jireh Satellite Campus** as an integrated school (hereinafter referred to as "the school").
- B** The Proprietor and the Minister wish to vary the Deed of Agreement to replace the Plan attached to the Second Schedule with a new Plan pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

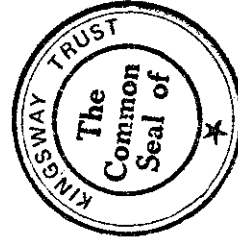
NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** Kingsway School's Jireh Satellite Campus be relocated from State Highway 27, Kumeu to Central Park Drive, Henderson, Waitakere.
2. **THAT** the Plan attached to the Second Schedule of the Deed of Agreement be deleted and replaced by the Plan attached hereto.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.

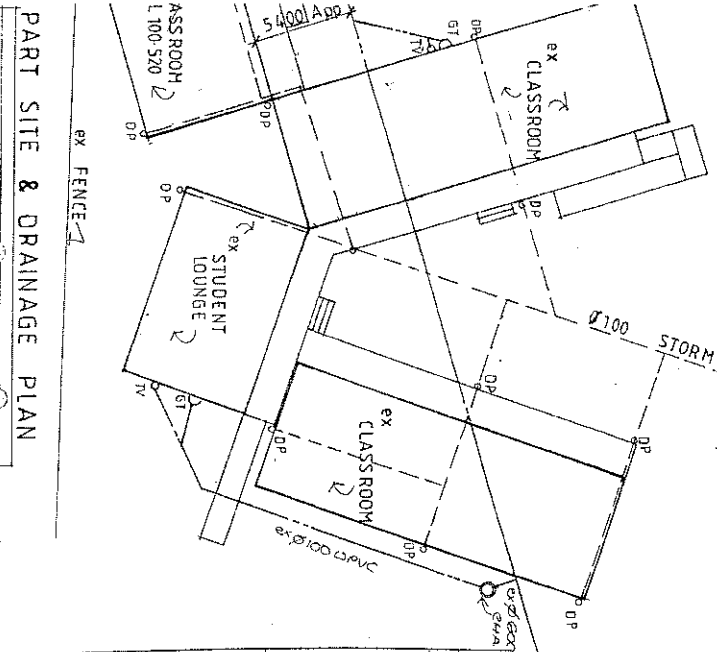
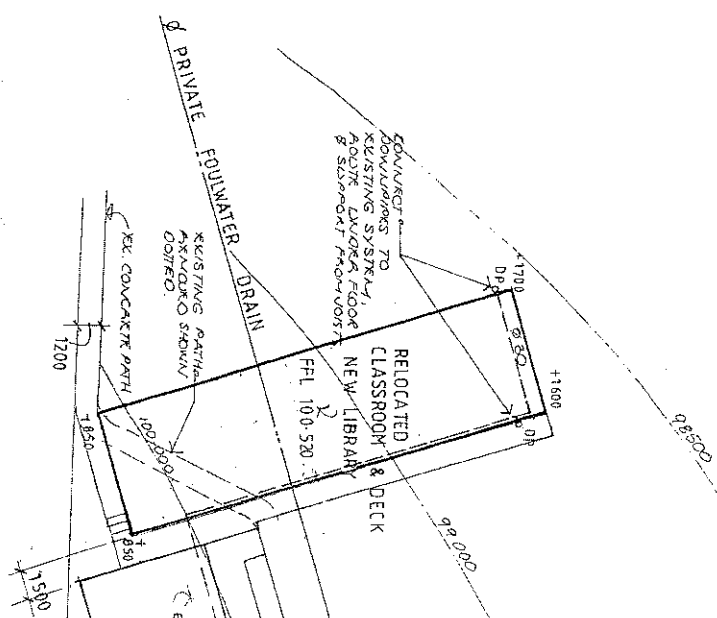
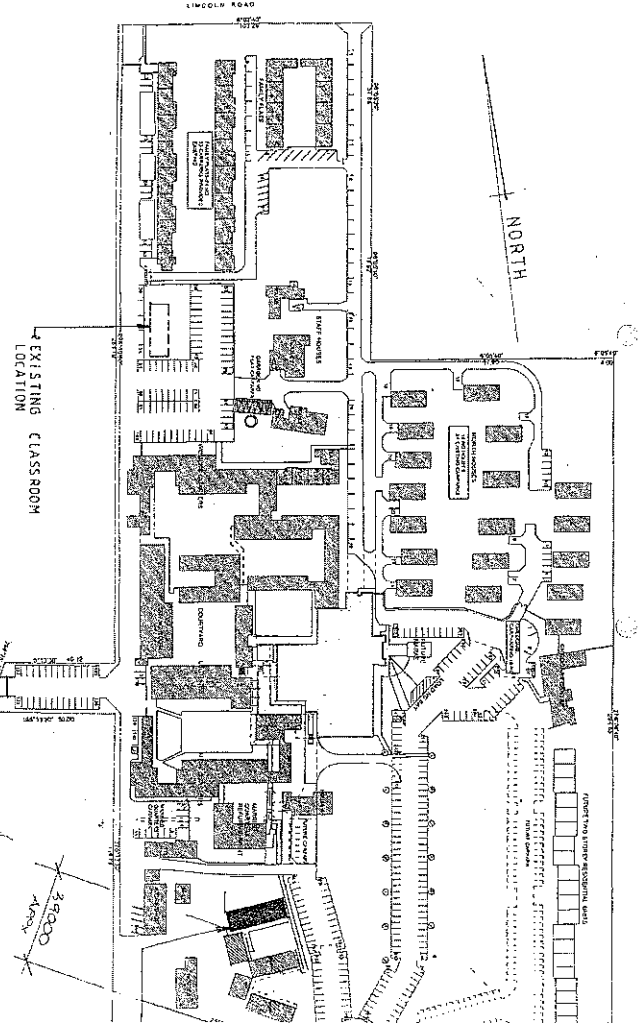
