

DEED OF AGREEMENT

OUR LADY OF THE ASSUMPTION SCHOOL, HOON HAY, CHRISTCHURCH

THIS DEED OF AGREEMENT is made on the 23rd day of August One thousand nine hundred and ninety-five (1995) BETWEEN THE ROMAN CATHOLIC BISHOP OF CHRISTCHURCH a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS


- A By Deed of Agreement bearing date the 2nd day of February 1981 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Our lady of the Assumption School, Hoon Hay, Christchurch as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. THAT the words "two hundred and twenty one (221)" in the 5th line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and fifty (250)" be substituted therefor.
2. THAT the Third Schedule of the original Deed of Agreement be amended by under "Building Requirements - Integrated Area" adding the words "One teaching space of 60m². This accommodation is to be provided as soon as the actual roll requires it."
3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
