

SUPPLEMENTARY DEED OF AGREEMENT

OUR LADY OF THE ROSARY SCHOOL, WAIWHETU

THIS DEED OF AGREEMENT is made on the 14th day of June One thousand nine hundred and ninety six (1996) **BETWEEN THE ROMAN CATHOLIC ARCHBISHOP OF THE ARCHDIOCESE OF WELLINGTON** a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A** By Deed of Agreement bearing date the Fourteenth (14) day of April, One thousand, nine hundred and eighty-one (1981) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **OUR LADY OF THE ROSARY SCHOOL, WAIWHETU** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister wish to vary the Deed of Agreement to amend Clause 8 of the Deed of Agreement and to replace the Plan attached to the Second Schedule with a new Plan pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1 THAT the words "one hundred and ninety (190)" in the fifth line in Clause 8 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and ten (210)" be substituted therefor.
- 2 THAT the Plan annexed to the Second Schedule of the Deed of Agreement be deleted and the Plan annexed hereto be substituted therefor.
- 3 THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the
