**BETWEEN LAKE TAUPO CHRISTIAN SCHOOL TRUST** (herein called "the Proprietor")

**AND HER MAJESTY THE QUEEN**, acting by and through the **MINISTER OF EDUCATION** (herein called the "Minister")

**WHEREAS:**

- A The Minister and the Proprietor, pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 (hereinafter called "the Act"), established Lake Taupo Christian School, 42 Kiddle Drive, Taupo as an integrated school (herein called "the School"). The terms on which the School was established are set out in the Integration Deed of Agreement dated 12 April 1999 (together with all variations and amendments herein called "the Deed of Agreement")
- B The Proprietor and Minister have agreed to amend clauses 18 and 19 of the Deed of Agreement pursuant to section 7(9) of the Act.

**NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:**

1. That clause 18 of the Deed of Agreement be amended by the deletion of the words "It is agreed that the maximum roll of the School shall be 75" and replacing them with "It is agreed that the maximum roll of the School shall be 120".
2. That clause 19(b) of the Deed of Agreement be amended by the deletion of the words "shall be limited to 10% of the roll of the School" and replacing them with "shall be limited to 8 pupils".
3. The clauses, conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein, but in all other respects the Deed of Agreement is confirmed.




