BACKGROUND

- A. The Minister and the Proprietor signed a deed dated 7 April 1999 as a Supplementary Agreement ("Supplementary Agreement") varying the Integration Agreement dated Tuesday, October 04, 1999 ("Integration Agreement") for Liberton Christian School, Dunedin ("School") pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.
- B. Under the Integration Agreement the Minister has an obligation to the Proprietor to maintain the School's premises. The Minister and the Proprietor annually in two ways;
 - (i) by the Minister funding the Board of Trustees of the School to carry out a certain part of the maintenance of the School premises; and
 - (ii) by the Minister paying a sum of money to the Proprietor for the Proprietor to carry out that part of the maintenance of the School premises not undertaken by the Board of Trustees of the School.
- C. The Minister at the Proprietor's request has agreed to amend the Supplementary Agreement to specify a fixed percentage as the depreciation annually by the Minister to the Proprietor to carry out that part of the of the School.
- D. Pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975 the Minister and the Proprietor have agreed to vary the Supplementary Agreement to the Integration Agreement by this supplementary agreement.

The parties agree as follows:

1. VARIATION OF SUPPLEMENTARY AGREEMENT


- The Supplementary Agreement dated 7 April 1999 varying the Integration Agreement for the School shall be varied as follows:
 - Clause 1.2.2 specifying the definition of "Depreciation Rate" shall be revoked and replaced with the following definition:
 - Clause 1.2.2 "Depreciation Rate" means four per cent (4%) of the depreciated value of state school buildings as set out in the "Statement of Accounting Policies" in the Ministry of Education's Annual Report";
