

SUPPLEMENTARY DEED OF AGREEMENT

LINDISFARNE COLLEGE, HASTINGS


THIS DEED OF AGREEMENT is made on the ^{Fifteen} 3 day of ²⁰¹⁵ November two thousand and ~~sixteen~~ (2016) BETWEEN **THE LINDISFARNE PROPRIETORS TRUST BOARD** ("the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A** By Deed of Agreement bearing date the 22nd day of December 1998 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Lindisfarne College, Hastings** as an integrated school (hereinafter referred to as "the School").
- B** The Proprietor and the Minister are now agreed on the need to amend Clause 19 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.


NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT** the words "five hundred and four (504) pupils" in line 5 of Clause 19 of the deed of Agreement be deleted and the words "five hundred and twelve (512)" be substituted therefor and in the 4th line "two hundred and sixty one (261) be deleted and two hundred and sixty nine (269) for the 2016 school year be substituted therefore.
- 2. THAT** the non-preference roll will remain at 5% of the maximum roll.
- 3. THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
