SUPPLEMENTARY AGREEMENT TO INTEGRATION AGREEMENT

SUPPLEMENTARY DEED OF INTEGRATION

THIS DEED OF AGREEMENT is made on the *17* day of *May* 2007

BETWEEN THE LINDISFARNE PROPRIETORS TRUST BOARD an incorporated body under the provision of the Charitable Trust Act 1957 ("the Proprietors").

AND HER MAJESTY THE QUEEN acting by and through the Ministry of Education ("the Minister").

WHEREAS

- A** By Deed bearing the date the 22nd day of December 1998 (hereinafter referred to as "the Deed"), the Minister and the Proprietor pursuant to Section 7 (2) of the Private Schools Conditional Integration Act 1975 established Lindisfarne College as an integrated school (hereinafter referred to as "the School").
- B** By Supplementary Deed of Integration ("the Supplementary Deed") dated the 22nd day of December 1999, the Minister and the Proprietor both varied and added to the Deed.
- C** By Supplementary Deed of Integration (the Supplementary Deed) dated the 17th day of August 2001, the Minister and the Proprietor both varied and added to the Deed.
- D** By Supplementary agreement of the Integration Agreement dated 26th July 2002 the Minister and the Proprietor both varied and added to the Deed.
- E** By Supplementary agreement of the Integration Agreement dated 14 May 2004 the Minister and the Proprietor both varied and added to the Deed.
- F** By Supplementary agreement of the Integration Agreement dated 4 July 2005 the Minister and the Proprietor both varied and added to the Deed.
- G** The Proprietor desires to vary the Deed in the manner set forth, in this Deed and the Minister has agreed to such changes pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THEREFORE THIS DEED OF AGREEMENT WITNESSETH AND IT IS

AGREED BETWEEN THE PARTIES HERETO AS FOLLOWS:


Handwritten signatures and initials, including a large signature and the initials 'RDS'.

1. **THAT** the Plan attached to this Supplementary Deed of Agreement is substituted as the Plan defining the School Premises and other improvements thereon in the Deed of Agreement **SAVE AND EXCEPT** those non-integrated buildings delineated in blue.

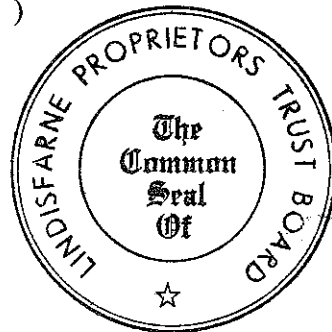
