

## SUPPLEMENTARY DEED OF AGREEMENT

### LINDISFARNE COLLEGE, HASTINGS


THIS DEED OF AGREEMENT is made on the 29 day of September two thousand and eleven (2011) between **The Lindisfarne Proprietors Trust Board** a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and **HER MAJESTY THE QUEEN** acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

#### WHEREAS

- A** By Deed of Agreement bearing date the 22<sup>nd</sup> day of December, one thousand nine hundred and ninety eight (1998) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Lindisfarne College, Hastings** as an integrated school (hereinafter referred to as "the school").
- B** The Proprietor and the Minister wish to vary the deed of Agreement to amend Clause 20 of the Deed Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

#### **NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:**

1. **THAT** the words "four hundred and seventy (470) " in the 3<sup>rd</sup> line of clause 20 of the Deed of Agreement be deleted from that Agreement and the words "four hundred and ninety six (496)" be substituted therefor and in the 4<sup>th</sup> line "two hundred and forty (240) be deleted and two hundred and fifty three (253)" be substituted therefore.
2. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
