two thousand and six (2006) BETWEEN THE NEW ZEALAND SEVENTH-DAY ADVENTIST SCHOOLS ASSOCIATION LIMITED being a body duly incorporated under the Companies Act 1955 (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing the date of 26th day of July, one thousand nine hundred and ninety three (1993) as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 established **Longburn Adventist College** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 20 of the Deed of Agreement pursuant to Section 7 (9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT the words "maximum roll of the School shall be 280" in the 4th line of clause 20 of the Deed of Agreement be deleted, and the words "maximum roll of the School shall be three hundred and fifty (350)" be substituted therefor.
- 2. That the covenants conditions and restrictions contained and implied in the Integration Agreements shall be read and construed subject to the modifications herein contained but in all other respects the Integration Agreements are confirmed.
