

SUPPLEMENTARY DEED OF AGREEMENT

MARIST SISTERS' COLLEGE, MOUNT ALBERT

THIS DEED OF AGREEMENT is made on the 8<sup>th</sup> day of December One thousand nine hundred and ninety-three (1993) BETWEEN THE MARIST SISTERS OF NEW ZEALAND TRUST BOARD a body corporate registered under the Religious Charitable and Education Trusts Act 1908 (hereinafter with its successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part

WHEREAS

- A By Deed of Agreement bearing date the 13th day of October 1981 as varied by subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Marist Sisters' College, Mount Albert as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

1. THAT the words "eighty eight (88)" in the 8th line of Clause 8 of the Deed of Agreement be deleted from that Agreement and the words "one hundred and twenty (120)" be substituted therefor.
  
2. THAT the proprietor will supply four (4) teaching spaces including one advanced laboratory when the roll of the school requires those teaching spaces.
  
3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
