

SUPPLEMENTARY DEED OF AGREEMENT

MARIST SCHOOL, HERNE BAY, AUCKLAND

THIS DEED OF AGREEMENT is made on the 3rd day of September Two thousand and ten (2010 BETWEEN THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF AUCKLAND a Corporation Sole (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 10th day of February 1983 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established **Marist School, Herne Bay, Auckland** as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.


NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. **THAT** the words "for boys and girls from New Entrants to Form Two (2)" in Recital B on page one of the Deed of Agreement be deleted from the agreement and the words "for girls and boys from New Entrants to Year Six (6) effective from Term One (1) 2011" be substituted therefore.
2. **THAT** the words "for boys and girls from New Entrants to Form Two (2)" in lines 1 and 2 of clause 23 of the Deed of Agreement be deleted from the agreement and the words "for girls and boys from New Entrants to Year Six (6) effective from Term One (1) 2011" be substituted therefore.
3. **THAT** the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.


