SUPPLEMENTARY DEED OF AGREEMENT

MARIST SCHOOL, HERNE BAY

THIS DEED OF AGREEMENT is made on the Cone thousand nine hundred and ninety-five (1995) BETWEEN THE ROMAN

CATHOLIC BISHOP OF AUCKLAND a "Corporation Sole" (hereinafter with his successors referred to as "the Proprietor") of the first part and HER MAJESTY THE QUEEN acting by and through the Minister of Education (hereinafter referred to as "The Minister") of the second part.

WHEREAS

- A By Deed of Agreement bearing date the 10th day of February 1983 as varied by any subsequent supplementary agreements (hereinafter referred to as "the Deed of Agreement"), the Minister and the Proprietor pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 established Marist School, Herne Bay as an integrated school (hereinafter referred to as "the School").
- B The Proprietor and the Minister are now agreed on the need to amend Clause 8 of the Deed of Agreement pursuant to section 7(9) of the Private Schools Conditional Integration Act 1975.

NOW THIS DEED OF AGREEMENT WITNESSETH THAT IT IS HEREBY COVENANTED AGREED AND DECLARED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. THAT the words "one hundred and twenty one (121) pupils" in the lst line in clause 8 of the Deed of Agreement be deleted from that Agreement and the words "two hundred and ten (210) pupils" be substituted therefor.
- 2. THAT the Proprietor will provide the following items of accommodation when the roll requires them: 4 additional classrooms (pupil / teacher ratio 1:26), 2 additional classrooms (pupil / teacher ration 1:35), an increase in library space from 32m2 to 56m2, an increase in staff room from 11m2 to 23m2, a school office of 8m2 and principals office of 11m2.
- 3. THAT the covenants conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein contained but in all other respects the Deed of Agreement is confirmed.
