Supplementary Deed of Agreement

*This deed of agreement is made on the Twentieth day of August 2001
and is between The Matamata Christian School Association Incorporated,
(hereinafter called "The Proprietor") and Her Majesty the Queen,
acting by and through the Minister of Education (hereinafter
called the "Minister").*

- A. *Whereas the Deed of Agreement date being the First day of May 1998 and varied under by any subsequent supplementary agreements (hereinafter called the "Deed of Agreement"), the Minister and the Proprietor, pursuant to section 7(2) of the Private Schools Conditional Integration Act 1975 (hereinafter called "the Act"), established Matamata Christian School at Matamata as an integrated school (hereinafter called "the School).*
- B. *The Proprietor and Minister are now agreed to amend clause 18 of the Deed of Agreement pursuant to section 7(9) of the Act.*
- C. *The Proprietor and Minister are now agreed to amend clause 19(2) of the Deed of Agreement pursuant to section 29(1) of the Act.*

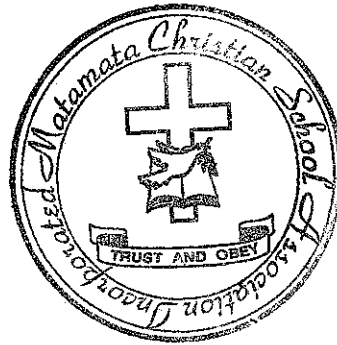
NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. *That the words in clause 18 "as at First of July 1997 the School Maximum Roll was 76" be deleted and replaced with the words "As at Twentieth day of August 2001, the School Roll was 90. It is agreed that the maximum roll of the School shall be 120".*
2. *That the words in clause 19(2) "shall be limited to ten percent of the roll of the School" be deleted and replaced with the words "shall be limited to nine students only, within the roll of the school".*
3. *The clauses, conditions and restrictions contained and implied in the Deed of Agreement shall be read and construed subject to the modifications herein, but in all other respects the Deed of Agreement is confirmed.*
