The Proprietor and the Minister pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 signed integration agreement on the twenty-first day of December 1995 for Middleton Grange School (hereinafter referred to as "the original deed of agreement"), subsequently signed a supplementary agreement on 29 August 1996 which increased

- supplementary agreement on 29 August 1996 which increased the maximum roll from 995 to 1035, subsequently signed a supplementary agreement on 8 September 1997 which increased the maximum roll from 1035 to 1080 and amended the Third Schedule by adding "General teaching space of 58 sq. m", subsequently signed a supplementary agreement on 9 April 1999 which provided for the Minister to pay to the Proprietor a sum of money annually for the maintenance of the school premises, and subsequently signed on 9 April 1999 a deed for the settlement of past maintenance disputes, subsequently signed a supplementary agreement on 25 February 2008 which increased the maximum roll from 1080 to 1140 and amended the Third Schedule by adding "Additional gross Hall area of 511sq m", and subsequently signed a supplementary agreement on 24 July 2009 which increased
