## SUPPLEMENTARY DEED OF AGREEMENT

## MIDDLETON GRANGE SCHOOL

This deed	is made on the 23 day of J417 2000
Between	The Trustees of The Christian Schools' Trust being the proprietor of Middleton Grange School the said proprietor being a body duly incorporated under the Charitable Trusts Act 1957 (hereinafter together with its successors and assigns called "the Proprietor") of the first part

And

**Her Majesty the Queen** acting by and through the Minister of Education (hereinafter called "Minister") of the second part

Whereas

- A. The Proprietor and the Minister pursuant to Section 7(2) of the Private Schools Conditional Integration Act 1975 signed integration agreement on the twenty-first day of December 1995 for Middleton Grange School (hereinafter referred to as "the original deed of agreement"), subsequently signed a supplementary agreement on 29 August 1996 which increased the maximum roll from 995 to 1035, subsequently signed a supplementary agreement on 8 September 1997 which increased the maximum roll from 1035 to 1080 and amended the Third Schedule by adding "General teaching space of 58 sq. m", subsequently signed a supplementary agreement on 9 April 1999 which provided for the Minister to pay to the Proprietor a sum of money annually for the maintenance of the school premises, subsequently signed on 9 April 1999 a deed for the settlement of past maintenance disputes, subsequently signed a supplementary agreement on 25 February 2008 which increased the maximum roll from 1080 to 1140 and amended the Third Schedule by adding "Additional gross Hall area of 511sq m", and subsequently signed a supplementary agreement on 24 July 2009 which increased the maximum roll from 1140 to 1200.
- B. The Proprietor and the Minister are now agreed on the need to amend Clause 21 of the original deed of agreement, and to amend the Third Schedule to the original deed of agreement pursuant to Section 7(9) of the Private Schools Conditional Integration Act 1975.

Now this deed of agreement witnesseth that it is hereby covenanted agreed and declared by and between the parties hereto as follows:

1

The number "1200" in the last line of clause 21 of the original deed of agreement be deleted from that agreement and the number "1290" be substituted therefore.

2

The Third Schedule to the original deed of agreement is hereby amended by adding:

"The proprietor shall provide

- a) One additional teaching space
- b) Additional gymnasium space to address deficiency of 0.8 gym teaching space."
